Verification statement for PZ Cussons for financial years 2023.

Verco Advisory Services Limited (Verco) was engaged by PZ Cussons (PZ) to provide independent verification of the greenhouse gas (GHG) emissions data reported with respect to PZ's operations for the period stated below. The verification process included a high-level analysis of the systems employed to manage data and a detailed risk-based assessment of evidence against the GHG inventory.

Boundaries of the verification: PZ Cussons and all subsidiaries worldwide on an operational control basis.

GHGs covered: carbon dioxide (CO2), methane (CH4), nitrous oxide (N2O), sulphur hexafluoride (SF6), nitrogen trifluoride (NF3) and hydrofluorocarbons (HFCs) or perfluorocarbons (PFCs) covered by the Kyoto Protocol.

Criteria against which verification conducted:

World Resources Institute (WRI)/World Business Council for Sustainable Development (WBCSD)
 Greenhouse Gas (GHG) Protocol Corporate Accounting and Reporting Standard (Scope 1 and 2)

GWP dataset used: The 2021 IPCC Sixth Assessment (AR6), GWP100

Verification Reference Standard: ISO 14064-3:2019 Greenhouse gases - Part 3: Specification with guidance for the validation and verification of greenhouse gas statements.

Period covered by the emissions verification:

June 1st 2022 to 31st May 2023 – FY23 or 2023

Verification opinion

Based on the verification work undertaken by Verco, we consider that all material GHG emission sources have been appropriately identified, measured, and reported. All findings that were identified during the audit fell below the threshold of ±5% so were not considered material, and all were rectified prior to the issue of this report and the publishing of the final inventory of GHG emissions.

Following the audit activities, it is Verco's conclusion that there is no evidence to suggest that the GHG emissions statement for FY23 are not materially correct, are not a fair representation of PZ's operations, and are not prepared in accordance with the WRI/ WBCSD GHG Protocol.

Validation statement

The quality of record keeping was found to be excellent with all documents well-kept and ordered. All backup and input data sources could be referenced easily. The audit functionality built into the inventory tool streamlined the process. Structural data corresponded with evidence and governance was well managed through a detailed protocol document.
