She is now responsible for overseeing operations and driving business growth in the Indonesian market. Ningcy will also be the first Indonesian national to lead the Indonesian business.
- Oghale Elueni has worked at PZ Cussons since 2021 and prior to this was General Manager, Sub-Saharan Africa and Managing Director West Africa for SC Johnson, preceded by a series of senior leadership roles at Procter & Gamble in Africa and the US. Oghale was already a member of the Group's Africa leadership team and now, for the first time, the Group has a Nigerian national leading its African business.
